In the event that the team is canceled, for any reason team members will be assigned by M.M.I. Global Evangelistic Association to another team of similar expense. M.M.I. Global Evangelistic Association is a highly disciplined organization with regulations in many areas, including conduct, dress and Christian life-style. These are explained in the packet of information sent to the accepted applicants.

Team members, leaders and staff adhere strictly to M.M.I. Global Evangelistic Association policies and are subject to dismissal for disobedience, without refund or reimbursement.
